**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, the County of San Mateo (County) has produced the Midcoast Action Plan for Parks and Recreation (Plan); and received the final report: "Improving Safety and Mobility along Highway 1 on the Unincorporated Midcoast of San Mateo County Project (Project)," and

**WHEREAS**, the County has engaged the communities of Half Moon Bay, Miramar, Princeton, and El Granada in the crafting of the report: "Improving Safety and Mobility along Highway 1 on the Unincorporated Midcoast of San Mateo County Project from Half Moon Bay North to the HMB Airport," which will serve to develop a community-vetted action plan to improve pedestrian safety along Highway 1; and

**WHEREAS**, the Project will develop strategies, measures, and recommendations to promote a network of transportation links throughout the County; and

**WHEREAS**, the Board of Supervisors' approval is now being requested to accept

and authorize acceptance of the Final Report and direct the Director of Parks, or designee, to develop an action plan with the community to implement the findings of the report.
