**WHEREAS**, San Mateo County Ordinance Code Section 4.04.260 requires that notice of the filing of said written report and of the time and place of a hearing thereon to be published once a week for two successive weeks prior to the date set for the hearing in a newspaper of general circulation in County Service Area No. 8.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** as follows:
