WHEREAS, both parties now wish to amend the Agreement by increasing the amount by \$28,183 for the purpose of enhancing services for older adults in the community with no change to the term; and

WHEREAS, there has been presented to this Board of Supervisors for its consideration and acceptance an Amendment, reference to which is hereby made for further particulars, and this Board of Supervisors has examined and approved the same

as to form and content and desires to enter into the same.
