RESOLUTION A) AUTHORIZING EXECUTION OF AN AGREEMENT WITH ALACRITAS INCORPORATED TO PROVIDE BODY REMOVAL SERVICE FOR THE TERM APRIL 1, 2009 THROUGH MARCH 31, 2012, IN AN AMOUNT NOT OT EXCEED ONE HUNDRED EIGHTY THOUSAND DOLLARS (\$180,000), NO ADDITIONAL NET COUNTY COST; AND B) AUTHORIZING THE CORONER OR HIS DESIGNEE TO EXECUTE CONTRACT AMENDMENTS WHICH MODIFY THE COUNTY'S MAXIMUM FISCAL OBLIGATION BY NO MORE THAN \$25,000 (IN AGGREGATE), AND/OR MODIFY THE CONTRACT TERM AND/OR SERVICES SO LONG AS THE MODIFIED TERM OR SERVICES ARE WITHIN THE CURRENT OR REVISED FISCAL PROVISIONS.

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, there has been presented to this Board of Supervisors for its consideration and acceptance, an agreement whereby Alacritas, Inc., agrees to provide Body Removal services to the San Mateo County Coroner's Office, and

WHEREAS, the Coroner or his designee to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 in aggregate, and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions, and

WHEREAS, both parties wish to enter into said agreement to body removal services for the period of April 1, 2009 to March 31, 2012 in the amount of \$180,000; and;

WHEREAS, this Board has been presented with a form of the agreement and has examined and approved it as to both form and content and desires to enter into said agreement; and

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors is authorized to execute the Agreement with Alacritas, Inc. to provide body removal services to San Mateo County Coroner for and on behalf of the County of San Mateo, and authorizing the Coroner of San Mateo or the Coroner's designee to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions and the Clerk of this Board shall attest the President's signature thereto.
