AN ORDINANCE AMENDING THE MASTER SALARY ORDINANCE

The Board of Supervisors of the County of San Mateo, State of California,
ordains as follows:

SECTION 1. Part 13 of the Ordinance is amended as indicated:

ORGANIZATION 15000 TAX COLLECTOR-TREASURER

1. Item E364S, Fiscal Office Assistant Series, is decreased by 1 position for a new total of 0 positions.
2. Item E350, Fiscal Office Specialist, is increased by 1 position for a new total of 18 positions.

ORGANIZATION 17000 HUMAN RESOURCES

1. Item D131, Program Services Manager I, is decreased by 1 position for a new total of 0 positions.
2. Item D049S, Human Resources Program Manager Series, is increased by 1 position for a new total of 1 position.
3. Item E479, Fiscal Office Services Supervisor, is decreased by 1 position for a new total of 0 positions.
4. Item E013-Y, Human Resources Technician – Confidential – Y-Rate, is increased by 1 position for a new total of 1 position.

ORGANIZATION 18000 INFORMATION SERVICES

1. Item V235, Information Technology Analyst, is increased by 3 positions for a new total of 3 positions.

ORGANIZATION 32000 PROBATION

1. Item V235, Information Technology Analyst, is decreased by 3 positions for a new total of 0 positions.

ORGANIZATION 70000 HUMAN SERVICES AGENCY

1. Item V235, Information Technology Analyst, is decreased by 1 position for a new total of 7 positions.
2. Item V234, Senior Information Technology Analyst, is increased by 1 position for a new total of 3 positions.

SECTION 2. The changes for Organization 15000, Section 1, Items 1 to 3, are effective retroactive to February 8, 2010. The changes for 70000, Section 1, Items 1 and 2 are effective retroactive to March 9, 2009. All other parts of this ordinance are effective at the start of the first pay period 30 days following adoption.




