**RESOLUTION APPROVING THE COUNTY OF SAN MATEO 2005 COMMUNITY-
SCALE GREENHOUSE GAS EMISSIONS INVENTORY AND THE COUNTY OF
SAN MATEO 2005 GOVERNMENT OPERATIONS GREENHOUSE GAS EMISSIONS
INVENTORY, WHICH WILL SERVE AS THE COUNTY'S BASELINE GREENHOUSE
GAS EMISSION LEVELS TO MEASURE FUTURE REDUCTIONS**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Board of Supervisors adopted the U.S. Cool Counties Climate Stabilization Declaration, Resolution No. 069053, on October 16, 2007 and the declaration requires the County to inventory its Greenhouse Gas (GHG) emissions, establish a plan and implement policies and programs to reduce GHG emissions, and to work closely with local state and federal governments to reduce county geographical GHG emissions; and

WHEREAS, on May 6, 2008 the Board of Supervisors adopted Resolution No. 069403 authorizing the execution of Climate Protection Grant Agreement No. 2008-107 (Grant) between the County of San Mateo and the Bay Area Air Quality Management District, which funded Public Works staff time to complete the GHG inventories: and,

WHEREAS, the Board of Supervisors has reviewed the County of San Mateo 2005 Community-Scale Greenhouse Gas Emissions Inventory and the County of San Mateo 2005 Government Operations Greenhouse Gas Emissions Inventory, which will serve as the County's baseline GHG emission levels to measure future Greenhouse Gas Emissions reductions.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that this Board of Supervisors hereby approves the County of San Mateo 2005 Community-Scale Greenhouse Gas Emissions Inventory and the County of San Mateo 2005 Government Operations Emissions Inventory.


