a future time by Task Orders issued by the Director of Public Works; and

WHEREAS, Consultant was one of the thirty (30) firms who submitted a proposal in response to a request for proposals for on-call engineering professional services, but with whom an agreement was not previously executed in connection with Resolution No. 070063; and

WHEREAS, the Director of Public Works has recommended that an agreement be entered into with the Consultant to perform various professional services to supplement staff and specifically to assist with work associated with Flood Control and Drainage System Study and Design; and

WHEREAS, this Board has considered the recommendation of the Director of Public Works and concurs with that recommendation.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

That the President of this Board of Supervisors be, and is hereby authorized and directed to execute said Agreement with Creegan + D'Angelo on behalf of County of San Mateo, and the Clerk of the Board shall attest to the President's signature thereto.
