RESOLUTION AUTHORIZING THE PRESIDENT OF THE BOARD TO EXECUTE AMENDMENT 2010-01 (AMENDMENT NO. 1) TO THE CAREADVANTAGE HOSPITAL SERVICE AGREEMENT WITH SAN MATEO HEALTH COMMISSION, DOING BUSINESS AS HEALTH PLAN OF SAN MATEO, INCREASING THE INPATIENT MENTAL HEALTH SERVICES PER DIEM RATE BY \$42.93, FROM \$1,129.78 TO \$1,172.71, PER ACUTE DAY EFFECTIVE JANUARY 1, 2011.

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, San Mateo Health Commission, doing business as Health Plan of San Mateo (HPSM,) and the County have entered into the CareAdvantage Hospital Service Agreement (the Agreement), effective January 1, 2009, whereby HPSM reimburses the County for providing care of patients who are members of the CareAdvantage Plan; and

WHEREAS, both parties wish to amend the Agreement to increase the reimbursement amount of inpatient mental health service payments to an all-inclusive per diem rate of \$1,172.71 per acute day; and

WHEREAS, the Board has considered the Amendment to the Agreement, has approved it as to both form and content, and desires to enter into it.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of the Board of Supervisors be and is hereby authorized and directed to

execute said Amendment 2010-01 (Amendment No. 1) for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signatures thereto.
