and using qualified engineering firms for various professional consulting services; and

WHEREAS, on July 22, 2008 the Board adopted Resolution number 069599,

authorizing an agreement with Mazzetti & Associates for on call mechanical and

engineering consulting services for a maximum amount of \$200,000; and

WHEREAS, the Director of Public Works has recommend that the Board of Supervisors authorize the execution of an amendment to the agreement, which would increase the County's maximum fiscal obligation by \$100,000, to a new contract total of not to exceed \$300,000; and

WHEREAS, this Board has considered and agrees with the recommendation of the Director of Public Works.
