**RESOLUTION APPROVING AND ADOPTING PLANS AND SPECIFICATIONS
INCLUDING CONFORMANCE WITH PREVAILING WAGE SCALE REQUIREMENTS
AND CALLING FOR SEALED BIDS ON TUESDAY, MAY 19, 2009 AT 2:30 P.M. FOR
ELECTIONS OFFICE ROOFING, 40 TOWER ROAD, SAN MATEO, CALIFORNIA
(PROJECT NO. PF047)**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, plans and specifications dated April 10, 2009 have been prepared and approved by the Director of Public Works for Elections Office Roofing, and said plans and specifications have been filed in the office of the Director of Public Works; and

WHEREAS, said specifications require that the contractors performing the work pay not less than the general prevailing rates of wages, as established by the Department of Industrial Relations, in the locality in which said work is to be performed for each type of workman needed to execute the contract.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that

1. Plans and specifications dated April 10, 2009 for the aforesaid project, are on file in the office of the Director of Public Works, to which reference is hereby made for further particulars, are hereby approved and adopted as the plans and specifications to be adhered to in letting and performing the work under a

contract for said improvements.

2. Said specifications require that the contractors performing the work pay not less than the general prevailing rates of wages, as established by the Department of Industrial Relations, in the locality in which said work is to be performed for each type of workman needed to execute the contract.
3. The Department of Public Works is authorized and directed to issue a call for sealed bids to be received by the Clerk of the Board of Supervisors, San Mateo County, on or before Tuesday, May 19, 2009 at 2:30 p.m. in said office in the Hall of Justice, Redwood City, California. Said bids will then be transmitted to the County Manager's Office in said Hall of Justice and be publicly opened and declared.
4. The Director of Public Works is authorized to extend the call for bid and bid opening up to sixty (60) days beyond the time and date set forth in this Resolution..
5. The Department of Public Works is further directed to cause the Notice inviting sealed bids to be published for two times in the Independent Newsgroup, a newspaper printed and published in this County, and to obtain an affidavit of said publication, a copy of which shall be placed on file with the Clerk of the Board of Supervisors.


