**AN ORDINANCE AMENDING ORDINANCE NUMBER 04475**

The Board of Supervisors of the County of San Mateo, State of California,  
ordains as follows:

**SECTION 1.** Part 4 of the Ordinance is amended as indicated:

**ORGANIZATION 55000 HEALTH ADMINISTRATION**

1. The salary for item D059, Health Services Finance Director, is changed to range 7860.

**SECTION 2.** Part 13 of the Ordinance is amended as indicated:
