RESOLUTION AUTHORIZING THE CONTROLLER TO CONTINUE PAYMENTS ON HEALTH SYSTEM CONTRACTS FROM JULY 1, 2010 THROUGH SEPTEMBER 30, 2010

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Agreements listed in Attachment A, incorporated by reference herein, expire on or before June 30, 2010, and new agreements have not been completed; and

WHEREAS, the Controller does not have the authority to make payments to these contractors between the expiration date and time of completion of the Agreements; and

WHEREAS, this Board wishes to continue payments to contractors listed in Attachment A through September 30, 2010 pending execution of new Agreements.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that this Board of Supervisors authorizes the Controller to continue payments through September 30, 2010, on said Agreements for and on behalf of the County, subject to the contractors' continued compliance with all terms and conditions of the most recent agreements with the County with the exception of the maximum payment term

provision. Said payments are to be in the amounts authorized by the Chief of the Health System or designee at the existing rates in the most recent agreements with the County.
