RESOLUTION AUTHORIZING THE: 1) PRESIDENT OF THE BOARD OF SUPERVISORS TO EXECUTE A LEASE/CONCESSION AGREEMENT WITH THREE ZERO VENTURES, INC OF A PORTION OF THE AIRPORT TERMINAL BUILDING AT 9850 CABRILLO HIGHWAY NORTH, HALF MOON BAY, CALIFORNIA, AT AN INITIAL RATE OF \$2,371.00 PER MONTH AND AN INITIAL UTILITY FEE OF \$1,250.00 PER MONTH, FOR A TERM OF FIVE YEARS FROM JANUARY 1, 2011 TO DECEMBER 31, 2015, WITH ONE OPTION TO EXTEND FOR AN ADDITIONAL FIVE YEARS, AND 2) COUNTY MANAGER OR HIS DESIGNEE TO ACCEPT OR EXECUTE NOTICES, OPTIONS AND DOCUMENTS ASSOCIATED WITH THE AGREEMENT INCLUDING, BUT NOT LIMITED TO, EXTENSION OR TERMINATION OF THE AGREEMENT UNDER THE TERMS SET FORTH THEREIN. (LEASE NO. 5323)

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California; that

WHEREAS, since 1994, Three Zero Ventures, Inc ("Three Zero") has operated

the Three Zero Café in the Half Moon Bay Airport Terminal Building; and

WHEREAS, since October 2004, Three Zero has operated on a month-to-month

basis in accordance with the holdover provision of the current agreement, and the County

and Three Zero wish to enter into a new long-term agreement; and

WHEREAS, there has been presented to this Board of Supervisors for its

consideration and acceptance a Lease/Concession Agreement, reference to which is hereby made for further particulars, whereby the County of San Mateo shall lease a portion of the Half Moon Bay airport terminal building to Three Zero at an initial rate of \$2,371.00 per month together with an initial utility fee of \$1,250.00 per month, for a term of five years from January 1, 2011 to December 31, 2015, with one option to extend for an additional five years; and
