**AN ORDINANCE AMENDING SECTIONS 2.02.020, 2.02.030, 2.02.040, 2.02.050 AND
2.02.060 OF CHAPTER 2.02, OF TITLE 2 OF THE SAN MATEO COUNTY
ORDINANCE CODE
ESTABLISHING THE BOUNDARIES OF THE SUPERVISORIAL DISTRICTS**
