WHEREAS, the Director of Public Works has recommended that an agreement be entered into with the five firms of DES Architects+Engineers, Inc., Brewer Fraser Holland Lotito, Architects, Hibser Yamauchi Architects, PHD Architects and HOK Architects to provide professional consulting services as may be needed and under the

direction of the Director of Public Works; and

WHEREAS, this Board has considered and concurs with the recommendation of the Director of Public Works; and

WHEREAS, this Board has been presented with a form of said Agreements and has examined and approved same as to both form and content, and desires to enter into same:
