**RESOLUTION REJECTING ALL BIDS RECEIVED FOR THE MORGUE
RENOVATION PROJECT AT SAN MATEO MEDICAL CENTER AND DIRECTING
THE DIRECTOR OF PUBLIC WORKS TO INFORM THE BIDDERS OF THIS
DETERMINATION**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, this Board of Supervisors did, on September 13, 2011 adopt Resolution No. 071636, which Resolution adopted the plans and specifications ("Plans and Specifications"), including conformance with prevailing wage scale requirements, and calling for sealed bids for the Morgue Renovation Project at the San Mateo Medical Center; and

WHEREAS, the Clerk of this Board of Supervisors did, in public on October 6, 2011 at 2:30 p.m., open and examine all sealed bids that were received in the specified time for the doing of the work referred to in said Resolution No. 071636; and

WHEREAS, the Board of Supervisors has caused an analysis of said sealed bids to be made by the Director of Public Works of the County of San Mateo, and has, in open session, fully reviewed and considered said bids and the analysis thereof; and

WHEREAS, the three apparent low bidders requested to withdraw their bids, the fourth apparent low bidder does not meet the required bid document requirements, and

the remaining bids exceed the estimated construction cost of \$509,563; and

WHEREAS, the Director of Public Works has recommended that all bids be rejected, and having this Board considered and concurred with the recommendation.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

1. All bids received on October 6, 2011 are hereby rejected.
2. The Director of Public Works is directed to inform all bidders of this determination.
