County to contract with Tèlecare Corporation to reserve and care for patient beds at  
Cordilleras Mental Health Rehabilitation Center for non-adherent TB patients in  
Northern California for the term of July 1, 2008 through June 30, 2009, in the amount of  
\$187,600; and


