ADOPTING PLANS AND SPECIFICATIONS, INCLUDING CONFORMANCE WITH FEDERAL PREVAILING WAGE SCALE REQUIREMENTS, FOR THE DEMOLITION OF COUNTY BRIDGE NO. 67 (STATE BRIDGE NO. 35C-043) ON CRYSTAL SPRINGS DAM IN THE UNINCORPORATED AREA OF SAN MATEO COUNTY; AND 2. AUTHORIZING THE PUBLICATION OF A NOTICE TO CONTRACTORS FOUR (4) TIMES IN A NEWSPAPER RECEIVING WIDE LOCAL CIRCULATION; AND 3. AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO CALL FOR SEALED PROPOSALS TO BE RECEIVED BY THURSDAY, JULY 8, 2010 AT 2:30 P.M., IN THE OFFICE OF THE CLERK OF THE BOARD OF SUPERVISORS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, a Notice of Determination was filed pursuant to the provisions as

required by the California Environmental Quality Act, on January 20, 2010, for the

Demolition of County Bridge No. 67 (State Bridge No. 35C-043) on Crystal Springs Dam

in the Unincorporated Area of San Mateo County; and

WHEREAS, the County of San Mateo applied for and has been approved to

receive Federal Highway Bridge Replacement and Rehabilitation funds from the Federal

Highway Administration for the demolition of this County-owned bridge and recently

received an authorization to proceed with the demolition phase for this project from the

Federal Highway Administration; and

WHEREAS, the County of San Mateo has requested the use of Federal

Highway Bridge Replacement and Rehabilitation funds from the Federal Highway Administration for the construction of this County-owned bridge and expects to receive authorization for the use of these funds at the appropriate time; and

WHEREAS, plans and specifications dated March 30, 2010 have been prepared and approved by the Director of Public Works for the above mentioned project, and said plans and specifications have been filed in the office of the Director of Public Works (the "plans and specifications"); and

WHEREAS, the plans and specifications require that the contractors performing the work pay not less than the general prevailing wages, as established by the U.S. Department of Labor on federally funded projects, in the locality in which said work is to be performed for each type of worker needed to execute the contract.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

- 1. The plans and specifications dated March 30, 2010 for the aforesaid project, which are on file in the office of the Director of Public Works, and to which reference is hereby made for further particulars, are hereby approved and adopted as the plans and specifications to be adhered to in letting and performing the work under a contract for said improvements described therein.
- Said specifications require that the contractors performing the work pay not less than the general prevailing wages, as established by the U.S. Department of Labor on federally funded projects, in the locality in which said work is to be

performed for each type of worker needed to execute the contract.

- 3. The Department of Public Works is authorized and directed to issue a call for sealed proposals and authorizes the Director of Public Works to call for bids and to set the bid opening date and time on or before <u>2:30 p.m., Thursday July 8,</u> <u>2010</u> in the office of the Clerk of the Board of Supervisors in the Hall of Justice, Redwood City, California. Said bids will be received by the Clerk of the Board of Supervisors and then transmitted to the County Manager's Office in said Hall of Justice and be publicly opened and declared.
- 4. The Director of Public Works is authorized to extend the call for bids and bid opening up to sixty (60) calendar days beyond the time and date originally set forth by the Board of Supervisors.
- 5. The Department of Public Works is further directed to cause the Notice inviting sealed proposals to be published for <u>four (4)</u> times in a <u>newspaper receiving</u> <u>wide local circulation</u>, and to obtain an affidavit of said publication, a copy of which shall be placed on file with the Department of Public Works.
