WHEREAS, the Board of Supervisors approved a Performance Incentives Program ("San Mateo County STARS") on December 5, 2006 to recognize and reward County programs that have demonstrated outstanding customer service and program performance; and

WHEREAS, the STARS Award recipients and amounts for the Program Performance, Customer Service and Green award categories are: Health System's Ambulatory Electronic Medical Records (\$35,000); Health System's Behavioral Health Quality Management Program (\$5,000); Department of Park's Sign Shop (\$2,500); and Health System's Cordilleras Vegetables Garden (\$2,500);

WHEREAS, the recommended STARS Honorable Mention recipients are: Human Services Agency's Green Jobs Academy (\$5,000), Department of Housing's Moving to Work Program (\$5,000), Human Resources Department's Workers' Compensation Program (\$5,000), Health System's Medical Psychiatry Clinic (\$5,000), Sheriff's Office Latent Print Processing Technician Program (\$2,500) and Health System's Palliative Care Consultative Services (\$2,500);
