WHEREAS, pursuant to state law, Woodside Elementary School District adopted Resolution No. 01-2009, authorizing a Special Election by mail ballot, to be held on Tuesday, May 5, 2009, to submit to the voters a ballot measure to authorize a qualified parcel tax, and requesting the Board of Supervisors to render specified services relating to the conduct of said Special Election;

WHEREAS, pursuant to state law, the San Carlos School District adopted
Resolution 11:08/09, authorizing a Special Election by mail ballot, to be held on
Tuesday, May 5, 2009, to submit to the voters a ballot measure to authorize a qualified
parcel tax, and requesting the Board of Supervisors to render specified services relating

to the conduct of said Special Election;

WHEREAS, the County's Chief Elections Officer has been asked to perform certain services in conjunction with this Election; and;

WHEREAS, the Chief Elections Officer is agreeable to providing said election services; and.

WHEREAS, in consideration of services and supplies to be provided by the Chief Elections Officer, the Jefferson Elementary School District, Woodside Elementary School District and the San Carlos School District will reimburse the County for the costs of said services and supplies.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors authorizes the Chief Elections Officer to render specified election services for the May 5, 2009 Special Election.
