RESOLUTION AUTHORIZING THE EXECUTION AND RECORDATION OF DECLARATION OF TRUST FOR EI CAMINO VILLAGE

RESOLVED, by the Board of Supervisors of the County of San Mateo, sitting as the Board of Commissioners of the Housing Authority of the County of San Mateo, State of California, that

WHEREAS, the Housing Authority of County of San Mateo acquired real property (APN: 008-121-190) to develop the public housing complex now known as El Camino Village; and

WHEREAS, soon after the property was acquired, the Housing Authority obtained funds from the U.S. Department of Housing and Urban Development (HUD) and three other funding sources to complete the construction of El Camino Village, and these three funding sources had recorded a total of four liens against the subject property; and

WHEREAS, the U.S. Department of Housing and Urban Development requires that a Declaration of Trust be recorded in superior lien position for all property acquired, developed, maintained, or assisted with funds from the U.S. Housing Act of 1937, federal law governing public housing agencies; and

WHEREAS the Declaration of Trust required by HUD was not recorded against the property; and

WHEREAS, the above-referenced three funding sources have all executed agreements to allow subordination of their respective liens to the Declaration of Trust; and

WHEREAS, there has been presented to the Board of Commissioners for its

consideration and acceptance, a Declaration of Trust reference to which is hereby made for further particulars, and the Board has examined and approved the same as to form and content.
