#### RESOLUTION CERTIFYING THE MILEAGE IN THE COUNTY MAINTAINED ROAD SYSTEM (PROJECT NO. R3001, F-331 [3C])

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Section 2121 of the California Streets and Highway Code provides that each year counties shall submit to the California Department of Transportation the additions to and deletions from their total mileage of maintained county roads; and

WHEREAS, the California Department of Transportation certified to the State Controller that the total mileage of maintained County roads in San Mateo County in 2007 was 315.88 miles; and

WHEREAS, the Director of Public Works has reported that as of December 31, 2008, 1.12 miles of road were deleted from the total mileage of maintained County roads since 2007; and

WHEREAS, the Director of Public Works has also reported that as of December 31, 2008, the total mileage of maintained County roads is 314.76 miles.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED based on the information provided by the Director of Public Works, that this Board certifies the changes in the County maintained mileage as described in Exhibit "A" attached hereto 039588 and made a part hereof, that the mileage of County maintained roads as of December 31, 2008 is certified to be 314.76.


