WHEREAS, Catering Connection was awarded this Revenue Agreement in the

amount of \$300,000 over a three year term of March 1, 2010 to February 28, 2013 to

provide catering services to the residents of Telecare Transitions;

said Board has examined and approved same as to both form and content and desires

to enter into the same.

A. The President of this Board of Supervisors is hereby authorized and directed to execute said Agreement for and on behalf of the County of San Mateo; and the Clerk of this Board shall attest the President's signature thereto; and B. The Director of the Human Services Agency or the Director's designee is hereby authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions..
