WHEREAS, the term of the Agreement is three years and four months with a

six year extension thereafter; and

WHEREAS, the JPA's payment to the COUNTY is \$1,624,516 during the remainder of this fiscal year (through June 30, 2010) and including FY 2010/11 (July 1, 2010 through June 30, 2011); and

WHEREAS, this Board of Supervisors has been presented with the form of this Agreement and has examined and approved the Agreement as to form and content and desires to enter into same:
