**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, Section 2121 of the California Streets and Highway Code provides that each year counties shall submit to the California Department of Transportation the additions to and deletions from their total mileage of maintained county roads; and

**WHEREAS**, the California Department of Transportation certified to the State Controller that the total mileage of maintained County roads in the County of San Mateo, as of December 31, 2008, was 314.76 miles; and

**WHEREAS**, the Director of Public Works has reported that as of December 31, 2009, 0.63 miles of road were added to the total mileage of maintained County roads during 2009; and

**WHEREAS**, the Director of Public Works has also reported that as of December 31, 2009, the total mileage of maintained County roads is 315.39 miles.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** based on the information provided by the Director of Public Works, that this Board certifies the


