# RESOLUTION ESTABLISHING NO PARKING ZONES IN EL GRANADA AND NORTH FAIR OAKS

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, California Vehicle Code Section 22507 and Section 7.28.010 of the County Ordinance Code allow the Board of Supervisors to establish parking zones that prohibit or restrict the stopping, parking, or standing of vehicles; and

WHEREAS, the Director of Public Works has recommended that no parking zones be created as noted herein; and

The Resolution incorrectly stated:

El Granada Boulevard (County Road No. 929), El Granada
 On the westerly side of El Granada Boulevard commencing at the southerly property line of 315 EL GRANADA BOULEVARD and extending southerly to the southerly property line of 435 EL GRANADA BOULEVARD.

The description should be corrected as follows:

El Granada Boulevard (County Road No. 929), El Granada
 On the easterly side of El Granada Boulevard commencing across from the

northerly to a point across from the southerly property line of 435 EL GRANADA BOULEVARD.

#### NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that:

- 1. No Parking Zones are established at the following locations:
  - Media Manual Media Me
  - El Granada Boulevard (County Road No. 929), El Granada
    On the easterly side of El Granada Boulevard commencing across from the southerly property line of 315 EL GRANADA BOULEVARD and extending northerly to a point across from the southerly property line of 435 EL GRANADA BOULEVARD.
  - El Granada Boulevard (County Road No. 929), El Granada
    On the southerly side of EL GRANADA BOULEVARD commencing at the southerly property line of 435 EL GRANADA BOULEVARD and extending easterly to the easterly property line 403 EL GRANADA
    BOULEVARD.

- ➤ <u>El Granada Boulevard (County Road No. 929), El Granada</u>

  In the EL GRANADA BOULEVARD rights-of-way around the entire median island located south of 424 EL GRANADA BOULEVARD.
  - El Granada Boulevard (County Road No. 929), El Granada
- On the northerly side of EL GRANADA BOULEVARD commencing at the intersection of KATHRYN AVENUE and extending westerly to the intersection of ISABELLA ROAD.
