WHEREAS, Pacific Gas and Electric Company has utilities located on the

Tower Road property, some of which were installed without an appropriate formal agreement, and PG&E now plans to upgrade the facilities; and

WHEREAS, County desires to grant to Pacific Gas and Electric Company a utility easement on the condition that the easement may be relocated under the terms provided for in the Grant of Easement and Agreement; and WHEREAS, this Board has examined and approved the Grant of Easement and Agreement as to both form and content, and desires to enter into same.
