WHEREAS, on February 1, 2003, the County of San Mateo and Vestar-

Athens/YCP II Half Moon Bay, L.L.C. ("Vestar"), the previous owner and operator of the

Ritz Carlton Hotel in Half Moon Bay, entered into a Ground Lease for a portion of a

County owned parcel on Miramontes Point Road, Half Moon Bay, California; and

WHEREAS, the leased property is utilized for access to an adjacent parking lot

for hotel employee parking; and

WHEREAS, in 2004, DTRS Half Moon Bay LLC ("DTRS") acquired the Ritz

Carlton Hotel and is successor in interest to the Ground Lease; and

WHEREAS, the Ground Lease expired in 2007, and DTRS has continued to use the property on a month-to-month basis in accordance with the holdover provision of the Lease, and the County and DTRS wish to enter into a new long-term agreement; and WHEREAS, there has been presented to this Board of Supervisors for its consideration and acceptance a Ground Lease, reference to which is hereby made for further particulars, whereby the County of San Mateo shall authorize DTRS to use a portion of a County owned parcel on Miramontes Point Road in Half Moon Bay, for access to an adjacent parking lot, at a monthly rent of \$530, for a term of three years, in accordance with the terms and conditions contained in said Agreement, and
