WHEREAS, CalRecycle has responded in agreement with the findings of the Review Report; and

WHEREAS, the draft Multi-Jurisdictional Non-Disposal Facility Element has been provided to the City and County Association of Governments for comment.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that this Board of Supervisors hereby:

- Approves the Countywide Integrated Waste Management Plan Multi-Jurisdictional
   Non-Disposal Facility Element for the County of San Mateo; and
- Directs the Director of Public Works to submit the Countywide Integrated Waste
   Management Plan Multi-Jurisdictional Non-Disposal Facility Element to CalRecycle
   and the cities in San Mateo County.
