## RESOLUTION AUTHORIZING THE PRESIDENT OF THE BOARD TO EXECUTE AMENDMENT ONE TO THE AGREEMENT WITH THE BELMONT-SAN CARLOS FIRE DEPARTMENT FOR THE PROVISION OF COUNTYWIDE HAZARDOUS MATERIALS (HAZMAT) EMERGENCY RESPONSE SERVICES, INCREASING THE AMOUNT NOT TO EXCEED BY \$500,236, FROM \$1,430,383 TO \$1,930,619, AND EXTENDING THE TERM ONE YEAR TO JUNE 30, 2011.

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Hazardous Materials Emergency Response Team (HazMat) was formed in 1985 through a Joint Powers Authority, and is a multi-agency response team which services all 21 cities and the unincorporated areas of the County; and

WHEREAS, on August 7, 2007, the County entered into an Agreement (Resolution No. 068906) with the Belmont-San Carlos Fire Department to provide hazardous materials emergency response services and established a framework for improved management, communication, accountability, and adequate cost reimbursement in the delivery of Countywide hazardous materials response services, for an amount not to exceed \$1,430,383, and a term commencing July 1, 2007 to June 30, 2010; and

WHEREAS, both parties now wish to amend the Agreement by increasing the amount not to exceed by \$500,236 from \$1,430,383 to \$1,930,619, and extending the term one year to June 30, 2011; and
