**RESOLUTION AUTHORIZING AN AMENDMENT TO MASTER SALARY
RESOLUTION 075338 TO DELETE ONE POSITION, ADD ONE POSITION,
RECLASSIFY ONE POSITION, ADD ONE SPECIAL COMPENSATION, AND
CONVERT ONE UNCLASSIFIED POSITION TO CLASSIFIED VIA MEASURE D**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

WHEREAS, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

WHEREAS, San Mateo County Ordinance No. 07303 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

NOW THEREFORE, IT IS HEREBY ORDERED that the Board of Supervisors authorizes an amendment to Master Salary Resolution 075338 as follows:

ORGANIZATION 12400 PUBLIC SAFETY COMMUNICATIONS

1. Section 5 – Special Compensation of the Master Salary Resolution is amended to add an eight percent differential pay for any represented Public Safety Communications employee who is designated by the PSC Director or his/her designee for rotation to the Gang Task Force. Assignment to this task force is

usually for two to three months and requires working independently offsite and in a fast-paced environment.

ORGANIZATION 15000 TREASURER-TAX COLLECTOR

1. Item E030S, Accountant Series is decreased by one position for a new total of zero positions.
2. Item E351, Fiscal Office Services Supervisor - Exempt is increased by one position for a new total of two positions.

ORGANIZATION 66000 SAN MATEO MEDICAL CENTER

1. Item G112S, Community Worker Series is decreased by three positions for a new total of three positions.
2. Item G117, Senior Community Worker is increased by three positions for a new total of five positions.
3. Item B182S, Community Program Specialist Series - Unclassified is decreased by one position for a new total of zero positions.
4. Item G226S, Community Program Specialist Series is increased by one position for a new total of two positions.

Effective Dates

1. Changes for Org 66000, Items 1 to 2 are effective retroactive to February 25, 2018.
2. All other changes are effective on the first pay period following adoption.
