RESOLUTION: 1) APPROVING THE 2018-2022 CONSOLIDATED PLAN AND THE FY 2018-19 ANNUAL ACTION PLAN PENDING NOTIFICATION OF HOUSING URBAN DEVELOPMENT ENTITLEMENT AWARDS FOR COMMUNITY DEVELOPMENT BLOCK GRANT, HOME INVESTMENT PARTNERSHIPS, AND EMERGENCY SHELTER GRANT, WITH ADJUSTMENTS TO BE MADE TO INDIVIDUAL AWARDS ON A PRO RATA BASIS ONCE THAT NOTIFICATION HAS BEEN ISSUED; AND 2) AUTHORIZING THE DIRECTOR OF THE DEPARTMENT OF HOUSING OR THE DIRECTOR'S DESIGNEE TO EXECUTE CONTRACTS FOR THE PROGRAMS AND PROJECTS AS INDICATED IN THE ANNUAL ACTION PLAN

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of

California, that

WHEREAS, pursuant to Section 570.201 of Title 24 of the Code of Federal

Regulations, regarding the Community Development Block Grant ("CDBG") Program,

CDBG assistance may be used to fund eligible activities to be carried out by public

agencies or by private nonprofit entities which are duly organized to undertake community

development; and

WHEREAS, the McKinney-Vento Homeless Assistance Act, 42 U.S.C. § 11301, et

seq., provides for the distribution of federal funds, including the Emergency Solutions Grant

("ESG") Program, for homelessness assistance to units of local governments, including

urban counties as defined under the CDBG Program; and

WHEREAS, the National Affordable Housing Act of 1990, 42 U.S.C. § 12701, et seq., provides for the distribution of federal funds through the HOME Investment

Partnerships Act ("HOME") Program to eligible entities and consortia; and

WHEREAS, the County of San Mateo has formed the San Mateo County HOME Consortium with the City of South San Francisco and the City of San Mateo for the purposes of receiving HOME funds to increase the supply of affordable housing in this County; and

WHEREAS, the United States Department of Housing and Urban Development ("HUD") requires that entitlement jurisdictions submit a five-year Consolidated Plan, approved by the Board in May 2013 for HUD submission and subject to a substantial amendment in 2016; and

WHEREAS, the Consolidated Plan establishes the priorities and goals for the allocation of funding from the U.S. Department of Housing and Urban Development (HUD) formula block grants including Community Development Block Grant (CDBG), HOME Investment Partnership (HOME), and Emergency Solutions Grants (ESG); and

WHEREAS, the Consolidated Plan includes the Year One Annual Action Plan which represents the first year of the County's Consolidated Plan for the use of CDBG, HOME, and ESG funds; and

WHEREAS, there has been presented to this Board for its consideration and acceptance the 2018-2022 Consolidated Plan and the FY 2018-19 Annual Action Plan.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

Board of Supervisors approves and accepts the 2018-2022 Consolidated Plan and the FY 2018-19 Annual Action Plan and authorizes the Director of the Department of Housing or the Director's designee, to submit the Consolidated Plan and the Year One Annual Action Plan, the related certifications, and all understandings and assurances contained therein to HUD, to take all necessary actions in connection with the submission of the Consolidated Plan and the Year One Annual Action Plan and the Year One Annual Action Plan, including providing additional information that the United States government may require, and to execute contracts, as approved by County Counsel, for the programs and projects as indicated in the FY 2018-19 Annual Action Plan.
