RESOLUTION AUTHORIZING: A) THE PRESIDENT OF THE BOARD OF SUPERVISORS TO EXECUTE A CONSTRUCTION CONTRACT WITH GONSALVES AND STRONCK CONSTRUCTION COMPANY, INC., FOR ADA IMPROVEMENTS TO THE WUNDERLICH PARK CARRIAGE HOUSE, FOR THE TERM OF JUNE 1, 2018 THROUGH DECEMBER 31, 2018 IN AN AMOUNT NOT TO EXCEED \$485,400; AND B) THE DIRECTOR OF PUBLIC WORKS TO EXECUTE SUBSEQUENT CHANGE ORDERS THAT WILL INCREASE THE COUNTY'S MAXIMUM FISCAL OBLIGATION BY NO MORE THAN \$48,50, OR 10% OF THE CONTRACT AMOUNT, AND/OR MODIFY THE CONTRACT TERM AND/OR SERVICES SO LONG AS IT DOES NOT CAUSE THE TOTAL COST OF CONSTRUCTION TO EXCEED THE CURRENT OR REVISED FISCAL PROVISIONS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of

California, that

WHEREAS, the San Mateo County Parks Department has developed plans to

make improvements to the Wunderlich Park Carriage House to improve access in

compliance with the Americans with Disability Act (ADA) of 1990; and

WHEREAS, this Board did on February 13, 2018, adopt Resolution No.

075717, which adopted plans and specifications and associated project costs including,

conformance with prevailing wage scale requirements and call for sealed bids; and

WHEREAS, the Deputy Clerk of this Board of Supervisors did, in public on

March 29, 2018, open and examine all sealed bids that were received in the specified

time for the work to be performed; and

WHEREAS, the lowest responsible bidder, Gonsalves and Stronck

Construction Company, Inc., submitted a bid in the amount of \$485,400 based on the

plans and specifications; and

WHEREAS, the project is funded with Measure K funds, and there are sufficient funds budgeted for this project.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

 It is in the best interest of the County of San Mateo to award the agreement for project, Wunderlich Park Carriage House ADA Improvements, to:

Gonsalves and Stronck Construction Company, Inc.

- 2. The County of San Mateo shall enter into a written agreement with Gonsalves and Stronck Construction Company, Inc., for the improvements of said project as required by the Plans and Specifications adopted by this Board of Supervisors, as hereinbefore mentioned, which Plans and Specification are on file in the office of the Director of Public Works of the County of San Mateo.
- 3. The President of this Board of Supervisors shall be, and is hereby, authorized and directed to execute a contract with Gonsalves and Stronck Construction Company, Inc., in the amount of \$485,400, for the term of June 1, 2018 to December 31, 2018, for the project described herein, subject to the Department of Public Works' receipt and approval of the Performance Bond and Payment Bond required to be posted by the Contractor with the County of San Mateo.
- 4. The Director of Public Works is authorized to execute subsequent change orders up

to a maximum aggregate amount, not to exceed \$48,540, or ten percent of the maximum amount payable under the agreement, and/or modify the contract term and/or services so long as it does not cause the total cost of construction to exceed the current or revised fiscal provisions.

5. The Clerk of the Board of Supervisors, County of San Mateo, is hereby authorized and directed to attest the signature of the President of this Board of Supervisors to said written agreement.
