RESOLUTION AUTHORIZING THE CHIEF INFORMATION OFFICER/DIRECTOR OF INFORMATION SERVICES DEPARTMENT OR HIS DESIGNEE TO EXECUTE AGREEMENTS WITH THE 28 VENDORS LISTED IN ATTACHMENT A, TO PROVIDE CONTINGENCY STAFFING SERVICES, FOR THE TERM OF JULY 1, 2018 THROUGH JUNE 30, 2021, FOR AN AGGREGATE AMOUNT NOT TO EXCEED \$27,000,000 BETWEEN ALL AGREEMENTS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Information Services Department (ISD) provides many types of Information Technology (IT) support and services to County departments including both operational and project support. Since 2006, ISD has regularly conducted Requests for Proposals (RFP) to establish multi-year agreements for as needed technology based contingency staffing services. In 2014, ISD expanded the number of vendors in the eligible pool leading to better vendor response times and expanded service offerings; and

WHEREAS, ISD released RFP No. ISD-20181835 in April of 2018 for contingency staffing services to refresh the list of eligible pre-approved vendors qualified to provide the services described therein; and

WHEREAS, ISD would like authorization to select from the pre-approved vendor lists to meet a variety of contingency staffing needs. This would allow ISD to choose a vendor from the Attachment A list and would authorize the Chief Information

Officer (CIO) or his designee to execute agreements, including those over \$100,000, for contingency staffing services throughout the term of July 1, 2018 through June 30, 2021, for an aggregate up to an amount not to exceed \$27,000,000; and

WHEREAS, the CIO would like to allocate \$10,000,000 of the total not to exceed amount to the Health Information Technology Department and \$8,000,000 to the Probation Department and delegate his authority to these department's Directors to enter into agreements pursuant to the terms and conditions approved by the Board.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Chief Information Officer or his designee is hereby authorized to execute agreements with the vendors on Attachment A, including agreements over \$100,000, for contingency staffing services for the term of July 1, 2018 through June 30, 2021, in an aggregate amount not to exceed \$27,000,000.
