RESOLUTION AMENDING THE DESIGNATION OF 'NO PARKING' ZONES IN THE PUBLIC RIGHT-OF-WAY ON WAVERLY AVENUE AND 5TH AVENUE IN THE NORTH FAIR OAKS, UNINCORPORATED AREA OF REDWOOD CITY

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, California Vehicle Code Section 22507 et al. and Section 7.30.010 of the County Ordinance Code allow the Board of Supervisors to establish parking zones that prohibit or restrict the stopping, parking, or standing of vehicles; and

WHEREAS, on June 28, 2005, the Board of Supervisors adopted Resolution No. 67421 to generally specify parking restrictions and regulations for 'No Parking' zones in the unincorporated area of the County; and

WHEREAS, the Director of Public Works has recommended that two 'No Parking' zones specified in Resolution No. 67421 be amended as noted herein; and

WHEREAS, the recommendation for parking restrictions was a result of a 'condition of approval' placed on the proposed Waverly Place Apartment (16-unit) development from the Planning and Building Department based on community input; and

WHEREAS, this Board has reviewed and concurs with the recommendation of the Director of Public Works.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that

two 'No Parking' zones designated by Resolution 67421 adopted by the Board of Supervisors on June 28, 2005 are hereby removed, and Resolution No. 67421 is amended accordingly:

Fifth Avenue (County Road No. R-23), North Fair Oaks

Delete the reference that created a No Parking zone on the northwesterly side of FIFTH AVENUE commencing at a point, 24 feet northeasterly of the intersection of WAVERLY AVENUE and extending northeasterly a distance of 30 feet, more or less.

Waverly Avenue (County Road No. R-340), North Fair Oaks

Delete the reference that created a 'No Parking' zone on the northeasterly side of WAVERLY AVENUE, commencing at the intersection of FIFTH AVENUE, and extending northwesterly a distance of 40 feet, more or less.

IT IS FURTHER DETERMINED AND ORDERED that two amended 'No Parking' zones be established at the following locations:

Fifth Avenue (County Road No. R-23) Redwood City

Along the northwesterly side of Fifth Avenue, beginning approximately 24 feet northeast of the intersection of Waverly Avenue, continuing northeasterly for a distance of approximately 140 feet.

Waverly Avenue (County Road No. R-340) Redwood City

Along the northeasterly side of Waverly Avenue, beginning approximately 42 feet northwest of the intersection of Fifth Avenue, continuing northwesterly for a

distance of approximately 115 feet.
