

**AMENDMENT NO. ONE TO AGREEMENT BETWEEN THE COUNTY OF SAN
MATEO AND HORIZON WATER AND ENVIRONMENT, LLC FOR ON-CALL
ENGINEERING AND PROFESSIONAL SERVICES**

THIS AMENDMENT TO THE AGREEMENT, dated November 17, 2015 by and between the COUNTY OF SAN MATEO, hereinafter called "County," and HORIZON WATER AND ENVIRONMENT, LLC, hereinafter called "Consultant," and, is entered into this _____ day of _____, 2018.

W I T N E S S E T H:

WHEREAS, the County and Consultant entered into an Agreement for on-call engineering and professional services on November 17, 2015; and

WHEREAS, the County and Consultant wish to amend the Agreement by increasing the not-to-exceed amount by \$500,000.00 to \$1,000,000.00 and extending the term from November 16, 2018 to November 16, 2020; and

WHEREAS, Amendment No. One to the Agreement will ensure consistency and efficiencies realized for the completion of the Routine Maintenance Program implemented by the County of San Mateo's Department of Public Works and Parks Department, and allow for additional on-call environmental review or permitting services for upcoming County projects on an as-needed basis and as requested by the County through the duration of the Agreement.

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO
AS FOLLOWS:**

1. Section 3 "Payments", of the Agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed One Million Dollars (\$1,000,000). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration.

2. Section 4 "Term", of the Agreement is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from November 17, 2015, through November 16, 2020.

3. The not-to-exceed amount as stated in Exhibit "B" of the original Agreement shall be amended to be \$1,000,000.
4. All other terms and conditions of the Agreement dated November 17, 2015, between the County and Consultant shall remain in full force and effect.
