WHEREAS, LINDA GIBBONS was sworn in as a San Mateo County Deputy Sheriff by Sheriff Brendan Maguire on September 30, 1985; and

WHEREAS, LINDA GIBBONS initially was assigned to the Main Jail and the North County Jail from 1985 through 1990; and

WHEREAS, LINDA GIBBONS maintained an outstanding record within the Sheriff's Office, working on a variety of assignments including Patrol, Women's Correctional Center, Training Unit and Investigations Bureau; and

WHEREAS, LINDA GIBBONS spent 16 years of her career as Detective Sergeant assigned to the Investigations Bureau, representing the Sheriff's Office on the Child Death Review Team, the Domestic Violence Death Review Team, the Domestic Violence Council Legal Process Committee and the Victim Services Steering Committee; and

WHEREAS, LINDA GIBBONS served under five different elected Sheriffs - Brendan Maguire, Leonard Cardoza, Don Horsley, Greg Munks and Carlos Bolanos - during her 33-year career; and

WHEREAS, LINDA GIBBONS was active in the Sheriff's Office Association as a Board member, the Organization of Sheriff's Sergeants (OSS) as a board member, received 70-plus letters of appreciation from Police Chiefs and Community Leaders, as well as five Captain's Commendations; and

WHEREAS, LINDA GIBBONS has been honored as the San Mateo County Employee of the Month in December 2003, secured a grant from the US DOJ in 2008 and worked collaboratively with CORA, Legal Aid, Domestic Violence Restraining Order Clinic and the Office on Violence Against Women to create the Sheriff's Office Domestic Firearms Compliance Unit; and

WHEREAS, LINDA GIBBONS received the Barbara Hammerman Domestic Violence Law Enforcement Award from the San Mateo County Domestic Violence Council in 2008 and the Peace Officer of the Year Award from the San Mateo County Trial Lawyers Association in 2009.

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of San Mateo County hereby honors SGT. LINDA GIBBONS, upon her retirement from the San Mateo County Sheriff's Office after an exemplary 33-year career of public service at the highest level of achievement and wishes her all the best in her future endeavors.
