### **RESOLUTION AUTHORIZING AN AMENDMENT TO MASTER SALARY RESOLUTION 075338 TO DELETE SEVEN POSITIONS, ADD SEVEN POSITIONS, AND ADJUST THE SALARY OF SIX CLASSIFICATIONS**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

**WHEREAS**, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

**WHEREAS**, San Mateo County Ordinance No. 07303 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

**NOW THEREFORE, IT IS HEREBY ORDERED** that the Board of Supervisors authorizes an amendment to Master Salary Resolution 076017 as follows:

#### **VARIOUS DEPARTMENTS**

1. Salary Range for Item E333, Office Assistant Intern is set at \$16.00 per hour.
2. Salary Range for Item E340, Office Assistant Summer Jobs for Youth is set at \$16.00 per hour.



3. Salary Range for Item I052, Intern/Fellow I is set at \$16.00 per hour.
4. Salary Range for Item I070, STEP Intern is set at \$18.75 to \$20.01 per hour.
5. Salary Range for Item E071, Library Aide – Extra Help is set at \$18.75 to \$20.01 per hour.
6. Salary Range for Item L046, Park Aide is set at \$18.75 to \$20.01 per hour.
