



Justification (Attach Memo if Necessary): This Appropriation Transfer Request will allow the Parks Department to transfer \$690,000 to the City of South Francisco for the purchase of additional public open space on Signal Hill in South San Francisco. The Parks Acquisition and Development Fund received funding from the South San Francisco Redevelopment Agency in 2007 for open spaces around San Bruno Mountain in South San Francisco, including the adjacent Signal Hill. Once complete, 20 acres of permanent open space will be added for habitat preservation as well as for walking trails for San Mateo County residents or visitors to enjoy. The land will be maintained by the South San Francisco Parks and Recreation Department.
