**ALL THAT CERTAIN REAL PROPERTY** BEING PORTION OF PULGAS RANCHO, SITUATE IN THE TOWN OF WOODSIDE, COUNTY OF SAN MATEO, STATE OF CALIFORNIA, BEING ALL OF LOT 24 AS SHOWN ON THAT CERTAIN MAP ENTITLED TRACT No. 667, WOODSIDE KNOLLS, UNIT No. TWO, FILED FOR RECORD JUNE 17, 1953 IN BOOK 37 OF MAPS AT PAGES 6 AND 7, SAN MATEO COUNTY RECORDS, ALSO BEING PORTIONS OF LANING DRIVE AS SHOWN ON SAID TRACT MAP No. 667, WOODSIDE KNOLLS No. TWO, AND ON THAT CERTAIN MAP ENTITLED TRACT No. 659, WOODSIDE KNOLLS, UNIT No. ONE, FILED FOR RECORD NOVEMBER 6, 1952 IN BOOK 36 OF MAPS AT PAGE 3, SAN MATEO COUNTY RECORDS, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

**BEGINNING** AT A POINT ON A NORTHWESTERLY LINE OF THE FAIR OAKS SEWER MAINTENANCE DISTRICT (DISTRICT) BOUNDARY ADOPTED ON MAY 23, 2006 BY **RESOLUTION NO 068008**, SAID POINT ALSO BEING THE SOUTHERLY MOST CORNER OF LOT 24 ON THE ABOVE-MENTIONED TRACT MAP No. 667, WOODSIDE KNOLLS, UNIT No. TWO, (37 MAPS 6-7);

1. THENCE FROM SAID **POINT OF BEGINNING**, ALONG THE SOUTHWESTERLY LINE OF SAID LOT 24, **NORTH 42°47'00" WEST, A DISTANCE OF 205.00 FEET** TO A POINT ON THE SOUTHEASTERLY LINE OF RIGHT OF WAY LINE OF LANING DRIVE, BOTH AS SHOWN ON THE ABOVE-MENTIONED TRACT MAP No. 659, WOODSIDE KNOLLS, UNIT No. ONE (36 MAPS 3), SAID POINT ALSO BEING ON THE SOUTHEASTERLY LINE OF THE FAIR OAKS SEWER MAINTENANCE DISTRICT (DISTRICT) BOUNDARY ADOPTED ON MAY 23, 2006 BY **RESOLUTION NO 070300**;
2. THENCE FROM LAST SAID POINT, NORTHEASTERLY ALONG SAID SOUTHEASTERLY (DISTRICT) LINE AND ALONG SAID COMMON LINE, **NORTH 47° 13'00" EAST, A DISTANCE OF 230.00 FEET** TO THE NORTHERLY MOST CORNER OF SAID LOT 24 (37 MAPS 6);
3. THENCE SAID NORTHEASTERLY LINE OF SAID LOT 24 (37 MAPS 6-7), **SOUTH 42°47'00" EAST, A DISTANCE OF 205.00 FEET** TO THE EASTERLY MOST CORNER OF LOT 24;


