**RESOLUTION AUTHORIZING AN AMENDMENT TO MASTER SALARY
RESOLUTION 076017 TO SET THE SALARY OF ONE POSITION, DELETE SEVEN
POSITIONS, ADD SEVEN POSITIONS, RECLASSIFY ONE POSITION, AND
CONVERT ONE POSITION TO CLASSIFIED VIA MEASURE D.**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

WHEREAS, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

WHEREAS, San Mateo County Ordinance No. 07303 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

NOW THEREFORE, IT IS HEREBY ORDERED that the Board of Supervisors authorizes an amendment to Master Salary Resolution 076017 as follows:

ORGANIZATION 12000 COUNTY MANAGER

1. Salary Range for Item B207, County Manager - Unclassified is set at \$160.00 per hour (\$332,800 per year).

ORGANIZATION 18000 INFORMATION SERVICES DEPARTMENT

1. Item V260S, IS Support Series is decreased by 1 position for a new total of 76 positions.
2. Item D114, ISD Division Manager is decreased by 1 position for a new total of 5 positions.
3. Item V300S, IS Supervisor Series is increased by 1 position for a new total of 12 positions.
4. Item D112, Assistant Director of Information Services, is increased by 1 position for a new total of 2 positions.

ORGANIZATION 25100 DISTRICT ATTORNEY'S OFFICE

1. Item B024S, Deputy District Attorney Series is decreased by 1 position for a new total of 52 positions.
2. Item B213, Chief Deputy District Attorney - Unclassified is increased by 1 position for a new total of 3 positions.
