**RESOLUTION: A) ACCEPTING THE CERTIFICATE OF THE CHIEF ELECTIONS OFFICER AS THE STATEMENT OF THE RESULTS OF THE VOTE AS DETERMINED BY THE OFFICIAL CANVASS OF THE NOVEMBER 6, 2018 STATEWIDE GENERAL ELECTION; AND B) DECLARING THE PERSONS ELECTED TO OR NOMINATED FOR CERTAIN OFFICES**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, the San Mateo County Chief Elections Officer has completed the official canvass of the completed returns of the votes cast at the Statewide General Election held throughout the County of San Mateo on November 6, 2018, has prepared in accordance with law a statement of votes polled at said election held on said date (the "Statement of the Vote"), and has presented a certified copy of the Statement of the Vote to this Board; and

**WHEREAS**, the Chief Elections Officer will deliver a duplicate of the certified Statement of the Vote to the California Secretary of State; and

**WHEREAS**, the Chief Elections Officer will deliver to each person elected a certificate of election, signed and authorized by the Chief Elections Officer; and

**WHEREAS**, the Chief Elections Officer has also determined that the number of persons who filed declarations of candidacy for certain offices does not exceed the number of positions available; and

**WHEREAS**, pursuant to Section 15400 of the Elections Code, the governing body of a jurisdiction shall declare elected or nominated to each office voted on at each election under its jurisdiction the person having the highest number of votes for that office or the person who was otherwise duly elected or nominated, and shall also declare the results of each election under its jurisdiction as to each measure voted on at the election; and

**WHEREAS**, this Board is the governing body for the County of San Mateo.

**NOW, THEREFORE, BE IT RESOLVED AND HEREBY ORDERED** that the Deputy Clerk of the Board shall enter upon the minutes of this meeting of this Board of Supervisors said Statement of the Vote polled at said election; and

**BE IT FURTHER RESOLVED** that said Statement of the Vote polled shall be and is hereby adopted as the official vote of said election throughout the County of San Mateo, State of California, on November 6, 2018; and
