**RESOLUTION AUTHORIZING AN AGREEMENT WITH CARAHSOFT TECHNOLOGY CORP., FOR THE PURPOSE OF PURCHASING SALESFORCE.COM, INC.'S PRODUCTS AND SERVICES FOR THE DEVELOPMENT, IMPLEMENTATION, AND MAINTENANCE OF THE ASSESSOR PROPERTY ASSESSMENT SYSTEM (APAS), FOR THE PERIOD OF JANUARY 8, 2019 THROUGH JANUARY 8, 2031, IN THE MAXIMUM AMOUNT OF \$5,495,533**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, on February 28, 2017, Assessor-County Clerk-Recorder-Elections (ACRE) released a Request for Proposals (RFP) for the Assessor Property Assessment System (APAS); and

**WHEREAS**, on December 11, 2018, this Board executed Resolution 076320 authorizing an agreement with Sapient Corporation to design, develop, implement, and maintain APAS utilizing Salesforce.com, Inc's platform technology; and

**WHEREAS**, Carahsoft Technology Corp. provides the Salesforce.com, Inc products and services necessary to develop, implement, and maintain APAS; and

**WHEREAS**, the agreement with Carahsoft Technology Corp. consists of: 1) a 13-year agreement for Salesforce.com, Inc.'s hosting and licensing services; and 2) a hosting and licensing contingency for additional user licenses, additional products, and data storage for the 13-year period of the agreement; and

**WHEREAS**, the term of the agreement is January 8, 2019 through January 8, 2031, in an amount not to exceed \$5,495,533; and

**WHEREAS**, this Board has examined the agreement and approved it as to both form and content and desires to enter into it.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the Board of Supervisors be and is hereby authorized and directed to execute said agreement for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

**BE IT FURTHER RESOLVED** that the Assessor-County Clerk-Recorder-Elections Officer or his/her designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions to purchase Salesforce.com, Inc's product and services from Carahsoft Technology Corp. for the ACRE APAS.
