# AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND LIEBERT CASSIDY WHITMORE

THIS AMENDMENT TO THE AGREEMENT, entered into this 9th day of April, 2019, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Liebert Cassidy Whitmore, hereinafter called "Contractor";

#### WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for services to assist the County on matters related to labor negotiations on November 6, 2018; and

WHEREAS, the parties wish to amend the Agreement to increase the amount of the agreement by \$100,000 for a new not to exceed amount of \$200,000 with no change to the term.

## NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

- 1. Section 3 of the agreement is amended to read as follows:
  - 3. Payments

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A1, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B1. County reserves the right to withhold payment if the County determines that the quantity or quality of the work performed is unacceptable. In no event shall the County's total fiscal obligation under this agreement exceed TWO HUNDRED THOUSAND DOLLARS (\$200,000). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration.

- 2. Original Exhibits A and B is replaced with Revised Exhibits A1 and B1, (rev. 4/9/2019).
- 3. All other terms and conditions of the agreement dated November 6, 2018, between the County and Contractor shall remain in full force and effect.

### Other Costs:

- Photocopies/\$0.15 per page
- Facsimile Transmittal/ \$0.25 per page

Contractor may bill the County for services rendered. In no event will contract exceed \$200,000.
