RESOLUTION AUTHORIZING AMENDMENTS TO AGREEMENTS WITH THREE (3) PROVIDERS FOR IT CONTINGENCY STAFFING: 314E CORPORATION; AGREEYA SOLUTIONS, INC; AND GENUENT GLOBAL, LLC, INCREASING THE AMOUNT BY \$800,000, TO AN NEW COMBINED AGGREGATE AMOUNT NOT TO EXCEED \$1,600,000, WITH NO CHANGE TO THE TERM OF THE AGREEMENT

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Administrative Services branch of the Human Services Agency

(HSA) provides IT application and operational support to the various branches of HSA;

and

WHEREAS, the Administrative Services branch has identified the need for IT contingency staffing agreements for specialized short-term projects, where current staff do not have expertise, to fill positions critical to HSA operations on a short-term basis while recruitments are conducted; and

WHEREAS, HSA conducted a Request for Proposals (RFP) in June 2017 and selected three contractors to award these agreements to: (1) 314e Corporation; (2) AgreeYa Solutions, Inc.; and (3) Genuent Global, LLC based on price competitiveness and the types of positions offered necessary to support the critical operations of HSA; and

WHEREAS, on October 31, 2017, this Board by resolution 075541 approved and authorized agreements with (1) 314e Corporation; (2) AgreeYa Solutions, Inc.; and (3) Genuent Global, LLC for the term of October 1, 2017 through September 30, 2020 for a combined aggregate amount not to exceed \$800,000; and

WHEREAS, additional workload has been identified in creating critical reports for our Financial Services Branch for budget monitoring and in system enhancements such as adding revenue project capability into the existing Budget Development System and a new tracking tool for services provided to our clients in our Job Center.

WHEREAS, amendments to these agreements are presented to this Board of Supervisors for its consideration and acceptance for an additional \$800,000 in order to address additional workload for a new combined aggregate amount not to exceed \$1,600,000 for the same term of October 1, 2017 through September 30, 2020.

NOW, THEREFORE, IT IS HEREBY RESOLVED that the President of this Board of Supervisors be hereby authorized and directed to execute said amendments for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto; and

BE IT FURTHER RESOLVED that the Human Services Agency Director or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate) for each Contractor for a maximum of \$75,000, and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
