

**AMENDMENT TO AGREEMENT  
BETWEEN THE COUNTY OF SAN MATEO AND GENUENT GLOBAL, LLC  
(FORMERLY GENUENT USA, LLC)**

THIS AMENDMENT TO THE AGREEMENT (the "Amendment"), entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Genuent Global, LLC, hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof; and

WHEREAS, the parties entered into an Agreement for the purpose of contingency staffing for County short-term IT projects or to fulfill urgent IT staffing needs until staffing can be hired under County recruitment process from October 1, 2017 through September 30, 2020 for a combined aggregate amount not to exceed \$800,000; and

WHEREAS, the parties wish to amend the Agreement to add additional funds and correct Contractor's name.

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:**

1. The Agreement is amended to read as follows:

All instances of "Genuent USA, LLC" is replaced by "Genuent Global, LLC"

2. Section 3 **Payments**, paragraph 2 is amended to read as follows:

Contractor acknowledges and agrees by signing this Agreement that County (Human Services Agency) has agreed to pay all contractors who provide IT contingency staffing services authorized collectively by single resolution, a copy which is attached hereto and incorporated by reference herein, an aggregate amount that shall not exceed ONE MILLION SIX HUNDRED THOUSAND DOLLARS (\$1,600,000), and that the funds available to pay each individual contractor are dependent upon the specific staffing services requested by County and the ability of each IT contingency staffing contractor to fulfill such staffing needs and individual negotiated rates that apply. Each contractor is only entitled to payment for actual costs incurred based on the rates shown in Exhibit B of its individual agreement for staffing services that have been fulfilled by request of County (Human Services Agency).
