**Location: Along both sides of Menlo Oaks Drive beginning at the intersection with Coleman Avenue and continuing southwesterly for approximately 1260ft, ending at the southwesterly property line of 241 Menlo Oaks Drive.**

#### **Discussion:**

The Department has evaluated the requests and determined that No Parking During Specified Hours Monday through Friday from 7:30 A.M. to 9:30 A.M and 2:00 P.M. to 4:00 P.M is necessary to prevent school affiliated vehicles from parking on Menlo Oaks Drive.

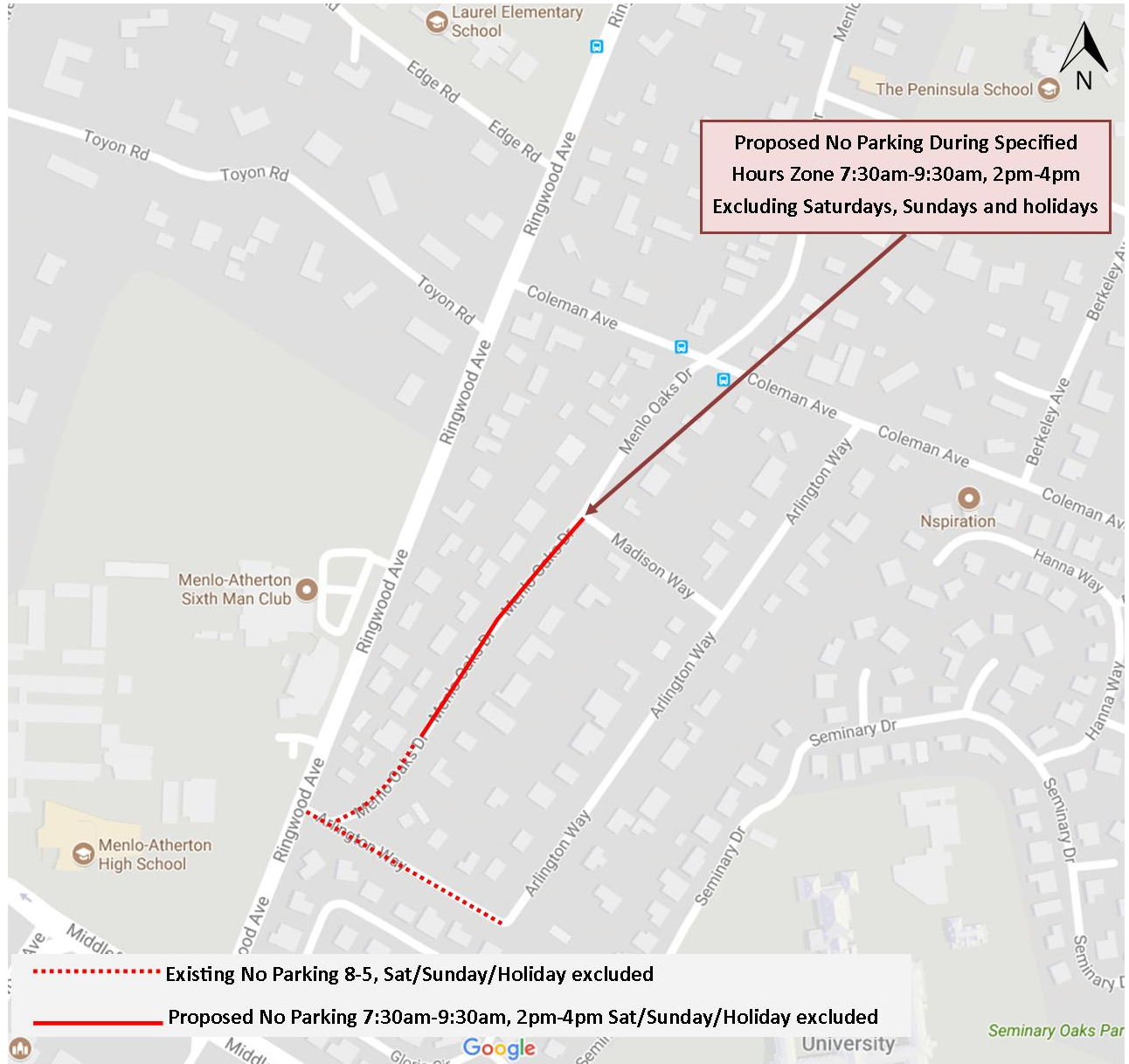
#### **Key Facts:**

- Restricting parking at this location will improve traffic flow and safety on Menlo Oaks Drive. Currently, vehicles parked along the side of the road force students to walk in the travel way.
- There are seven respondents in objection and seventeen in support for this item.
- Supporters cite increased safety for pedestrians and cyclists as well as reduced, litter, noise, and high school student traffic.
- Objector's voice concern about spillover parking to adjacent streets, specifically, Arlington Way. Arlington Way already has limited parking restrictions.
- The Menlo Oaks District Association approached homeowners on Arlington Way as well as those homeowners on the 500 block of Menlo Oaks Avenue to submit parking petitions; so additional petitions may be forthcoming.
- Petitions received in Attachment B are in favor of the proposed parking restrictions.

#### **Discussion:**

The Department has evaluated the requests and determined that No Parking During Specified Hours Monday through Friday from 8 AM to 5 PM is necessary to prevent school affiliated vehicles from parking on Madison Way.

#### **Key Facts:**

- Restricting parking at this location, will improve traffic flow and safety on Madison Way. As there are no sidewalks in this area, vehicles parked along the side of the road currently force students to walk in the travel way.
- There was one objection and eight in support of this item.
- The objector states that current conditions are adequate for bicycle and pedestrian safety.
- Petitions received in Attachment B are in favor of the proposed parking restrictions.
