WHEREAS, on October 20, 2015, the parties executed an Amendment to the Agreement to extend the term through October 31, 2016, and increase the amount by \$45,423, for a not to exceed amount of \$130,683; and
WHEREAS, on October 4, 2016, the parties executed an Amendment to the Agreement to extend the term through October 31, 2017, and increase the amount by \$49,965.30, for a not to exceed amount of \$180,648.30; and
WHEREAS, the parties wish to amend the Agreement for continued e-mail subscription services, extending the term through October 31, 2018, and increasing the amount by \$54,961.83, for a not to exceed amount of \$235,610.13.
