On 32 years of distinguished service to San Mateo County

WHEREAS, Regina Wilson-Henry served San Mateo County for over 32 years and is retiring in March 2018 as the Deputy Chief Probation Officer, Adult and Realignment Services Division for the Probation Department; and

WHEREAS, Regina began her career in public service as an extra help Group Supervisor I at the San Mateo County Juvenile Hall in November 1985 and was promoted to a full time Group Supervisor II in July 1988 then subsequently as Group Supervisor III in November 1989; she became an Institution Services Manager in September 1994 and was promoted to Probation Services Manager II with oversight on the juvenile hall and camps where she was dedicated to ensuring the safety and security of all detained youth as well as providing exceptional leadership to staff responsible for the day to day operations of the facility; in September 2006 she was instrumental with the transition to the new juvenile hall at the Youth Services Center; and

WHEREAS, in 2010, **Regina** was promoted to Deputy Chief Probation Officer, of the Juvenile Services Division, and eventually the Adult Services Divisions where she provided direction and guidance notably during the implementation of the specialty courts and state legislation initiatives such as Assembly Bill 109 Public Safety Realignment; and she symbolizes the core values of the Probation Department through her ability to foster teamwork, provide leadership, maintain integrity, exemplify professionalism, and recognize excellence; and

WHEREAS, Regina served as the State President for the California Association of Probation Services Administrators providing governance and collaboration with probation departments throughout the state; and

WHEREAS, Regina was instrumental in improving the lives of San Mateo County residents through her leadership and partnership with the San Mateo County Gang Task Force, the San Mateo County Narcotics Task Force, and local law enforcement special operations; and is a passionate public servant, mentor, and inspiration whose dedication and professionalism is admired by all of those who have the pleasure of working with her.
