**RESOLUTION: A) CONSOLIDATING THE STATEWIDE GENERAL ELECTION, TO BE HELD ON TUESDAY, NOVEMBER 6, 2018, WITH ELECTIONS CALLED BY THE SAN MATEO COUNTY BOARD OF EDUCATION, BELMONT-REDWOOD SHORES SCHOOL DISTRICT, CABRILLO UNIFIED SCHOOL DISTRICT, JEFFERSON ELEMENTARY SCHOOL DISTRICT, JEFFERSON UNION HIGH SCHOOL DISTRICT, LA HONDA-PESCADERO UNIFIED SCHOOL DISTRICT, PORTOLA VALLEY SCHOOL DISTRICT, RAVENSWOOD CITY SCHOOL DISTRICT, REDWOOD CITY ELEMENTARY SCHOOL DISTRICT, SAN BRUNO PARK SCHOOL DISTRICT, SAN MATEO COUNTY COMMUNITY COLLEGE DISTRICT, SAN MATEO-FOSTER CITY ELEMENTARY SCHOOL DISTRICT, SOUTH SAN FRANCISCO UNIFIED SCHOOL DISTRICT, CITY OF BELMONT, CITY OF BRISBANE, TOWN OF COLMA, CITY OF DALY CITY, CITY OF EAST PALO ALTO, CITY OF FOSTER CITY, CITY OF HALF MOON BAY, CITY OF MENLO PARK, CITY OF MILLBRAE, CITY OF PACIFICA, CITY OF REDWOOD CITY, CITY OF SAN CARLOS, CITY OF SOUTH SAN FRANCISCO, TOWN OF WOODSIDE, BROADMOOR POLICE PROTECTION DISTRICT, GRANADA COMMUNITY SERVICES DISTRICT, MENLO PARK FIRE PROTECTION DISTRICT, MIDPENINSULA REGIONAL OPEN SPACE DISTRICT, MID-PENINSULA WATER DISTRICT, MONTARA WATER AND SANITARY DISTRICT, SAN MATEO COUNTY HARBOR DISTRICT, SAN MATEO COUNTY TRANSIT DISTRICT, AND SEQUOIA HEALTHCARE DISTRICT; AND B) AUTHORIZING THE COUNTY'S CHIEF ELECTIONS OFFICER TO RENDER SPECIFIED ELECTION SERVICES IN CONJUNCTION THEREWITH.**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, Sections 10400 through 10418 of the Elections Code authorize the consolidation of elections that are called to be held on the same day in or within the same territory upon the order of the governing body or bodies calling the elections, the consolidation may be ordered by the County Board of Supervisors upon request, and the consolidated election shall be held in all respects as if it were one election, with the

returns being canvassed by the County's Chief Elections Officer;

**WHEREAS**, absent other arrangements or applicable law, the costs of any school district election shall be borne by the school district holding the election pursuant to Section 5421 of the Education Code, and any city or district shall reimburse the County in full for the services performed by the County's Chief Elections Officer in accordance with Division 10 of the Elections Code;

**WHEREAS**, pursuant to state law, the San Mateo County Board of Education, Belmont-Redwood Shores School District, Cabrillo Unified School District, Jefferson Elementary School District, La Honda-Pescadero Unified School District, Ravenswood City School District, Redwood City Elementary School District, San Bruno Park School District, San Mateo County Community College District, and South San Francisco Unified School District are required to hold regularly-scheduled governing board elections, and the named jurisdictions have notified the County's Chief Elections Officer of the number of seats to be elected and the relevant policies for breaking a tie vote, and the named jurisdictions are requesting an election as more candidates have filed to run for office in the named jurisdictions than there are seats available;

**WHEREAS**, pursuant to state law, the Broadmoor Police Protection District, Granada Community Services District, Menlo Park Fire Protection District, Midpeninsula Regional Open Space District, Mid-Peninsula Water District, Montara Water and Sanitary District, San Mateo County Harbor District, and Sequoia Healthcare District are required to hold regularly scheduled governing board elections, and the named jurisdictions have notified the County's Chief Elections Officer of the number of seats to be elected and the boundaries of the district, and the named jurisdictions are requesting

an election as more candidates have filed to run for office in the named jurisdictions than there are seats available; and

**WHEREAS**, pursuant to state law, the governing board of the Jefferson Elementary School District adopted Resolution No. 18-07-25, giving notice of holding a special election to be held on November 6, 2018, for the purpose of submitting a bond measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor;

**WHEREAS**, pursuant to state law, the governing board of the Jefferson Union High School District adopted Resolution No. 2018/19-5, giving notice of holding a special election to be held on November 6, 2018, for the purpose of submitting a parcel tax measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor;

**WHEREAS**, pursuant to state law, the governing board of the Portola Valley School District adopted Resolution No. 12-2018, giving notice of holding a special election to be held on November 6, 2018, for the purpose of submitting a bond measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor;

**WHEREAS**, pursuant to state law, the governing board of the San Bruno Park School District adopted Resolution No. 18/07-01, giving notice of holding a special election to be held on November 6, 2018, for the purpose of submitting a bond measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor;

**WHEREAS**, pursuant to state law, the governing board of the San Mateo-Foster

City Elementary School District adopted Resolution No. 28/17-18, giving notice of holding a special election to be held on November 6, 2018, for the purpose of submitting a parcel tax measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor;

**WHEREAS**, pursuant to state law, the governing board of the San Mateo County Transit District adopted Resolution Nos. 2018-29 and 076022, giving notice of holding a special election to be held on November 6, 2018, for the purpose of submitting a sales tax measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor;

**WHEREAS**, pursuant to state law, the City Council of the City of Belmont adopted Resolution Nos. 2018-057, 2018-061, 2017-090, and 2017-091, giving notice of holding a regularly scheduled general municipal election to be held on November 6, 2018, for the purpose of electing three city council members for a term of four years each, submitting to Belmont voters a hotel room tax measure and two Charter amendment measures, and requesting the County's Chief Elections Officer to render specified election services to the City therefor;

**WHEREAS**, pursuant to state law, the City Council of the City of Brisbane adopted Resolution No. 2018-63, giving notice of holding a regularly scheduled general municipal election to be held on November 6, 2018, for the purpose of submitting to Brisbane voters a General Plan amendment measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor;

**WHEREAS**, pursuant to state law, the City Council of the Town of Colma adopted Resolution Nos. 2018-23, 2018-09, 2018-10, and 2018-11, giving notice of

holding a regularly scheduled general municipal election to be held on November 6, 2018, for the purpose of electing two city council members for a term of four years each, submitting to Colma voters a transient occupancy tax measure, and requesting the County's Chief Elections Officer to render specified election services to the Town therefor;

**WHEREAS**, pursuant to state law, the City Council of the City of Daly City adopted Resolution Nos. 18-76, 18-109, 18-110, and 18-111, giving notice of holding a regularly scheduled general municipal election to be held on November 6, 2018, for the purpose of electing three city council members for a term of four years each, submitting to Daly City voters a business license tax measure, a transient occupancy tax measure, and a cannabis business tax measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor;

**WHEREAS**, pursuant to state law, the City Council of the City of East Palo Alto adopted Resolution Nos. 4987, 4988, and 5005, giving notice of holding a regularly scheduled general municipal election to be held on November 6, 2018, for the purpose of electing two city council members for a term of four years each, submitting to East Palo Alto voters a commercial office space parcel tax measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor;

**WHEREAS**, pursuant to state law, the City Council of the City of Foster City adopted Resolution Nos. 2018-46, 2018-65, and 2018-66, giving notice of holding a regularly scheduled general municipal election to be held on November 6, 2018, for the purpose of electing two city council members for a term of four years each, submitting to

Foster City voters a transient occupancy tax measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor;

**WHEREAS**, pursuant to state law, the City Council of the City of Half Moon Bay adopted Resolution Nos. C-2018-47, C-2018-48, C-2018-61, C-2018-62, and C-2018-84, giving notice of holding a regularly scheduled general municipal election to be held on November 6, 2018, for the purpose of electing three city council members for a term of four years each, submitting to Half Moon Bay voters a commercial cannabis activities measure, three advisory measures, and a cannabis business tax measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor;

**WHEREAS**, pursuant to state law, the City Council of the City of Menlo Park adopted Resolution No. 6442, giving notice of holding a regularly scheduled general municipal election to be held on November 6, 2018, for the purpose of electing three city council members for a term of four years each, and requesting the County's Chief Elections Officer to render specified election services to the City therefor;

**WHEREAS**, pursuant to state law, the City Council of the City of Millbrae adopted Resolution Nos. 18-43, 18-44, 18-45, 18-53, and 18-55, giving notice of holding a regularly scheduled general municipal election to be held on November 6, 2018, for the purpose of electing two city council members for a term of four years each, submitting to Millbrae voters a bond measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor;

**WHEREAS**, pursuant to state law, the City Council of the City of Pacifica adopted Resolution No. 26-2018, giving notice of holding a regularly scheduled general

municipal election to be held on November 6, 2018, for the purpose of electing three city council members for a term of four years each, and requesting the County's Chief Elections Officer to render specified election services to the City therefor;

**WHEREAS**, pursuant to state law, the City Council of the City of Redwood City adopted Resolution Nos. 15682, 15683, 15684, 15692, 15693, and 15694, giving notice of holding a regularly scheduled general municipal election to be held on November 6, 2018, for the purpose of electing three city council members for a term of four years each, submitting to Redwood City voters a cannabis business tax measure, a transactions and use (sales) tax measure, and a Charter amendment measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor;

**WHEREAS**, pursuant to state law, the City Council of the City of San Carlos adopted Resolution Nos. 2018-055, 2018-062, 2018-063, 2018-064, 2018-070, 2018-071, and 2018-072, giving notice of holding a regularly scheduled general municipal election to be held on November 6, 2018, for the purpose of electing three city council members for a term of four years each, submitting to San Carlos voters a transient occupancy tax measure and a cannabis business tax measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor;

**WHEREAS**, pursuant to state law, the City Council of the City of South San Francisco adopted Resolution Nos. 90-2018, 85-2018, and 86-2018, giving notice of holding a regularly scheduled general municipal election to be held on November 6, 2018, for the purpose of electing three city council members and a city clerk for a term

of four years each, submitting to South San Francisco voters a transient occupancy tax measure and a cannabis business license tax measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor;

**WHEREAS**, pursuant to state law, the Town Council of the Town of Woodside adopted Resolution Nos. 2018-7220 and 2018-7236, giving notice of holding a regularly scheduled general municipal election to be held on November 6, 2018, for the purpose of electing one town council member for a term of two years, and three town council members for a term of four years each, and requesting the County's Chief Elections Officer to render specified election services to the Town therefor;

**WHEREAS**, each of the aforementioned districts and municipalities has requested their respective elections to be consolidated with the November 6, 2018, Statewide General Election;

**WHEREAS**, the County's Chief Elections Officer is agreeable to providing specified election services as duly requested and enumerated above in conjunction with the Statewide General Election to be held on Tuesday, November 6, 2018;

**WHEREAS**, in consideration of the services and supplies to be provided by the Chief Elections Officer in conducting said election, the San Mateo County Board of Education, Belmont-Redwood Shores School District, Cabrillo Unified School District, Jefferson Elementary School District, Jefferson Union High School District, La Honda-Pescadero Unified School District, Ravenswood City School District, Redwood City Elementary School District, San Bruno Park School District, San Mateo County Community College District, San Mateo-Foster City Elementary School District, South San Francisco Unified School District, City of Belmont, City of Brisbane, Town of Colma,



City of Daly City, City of East Palo Alto, City of Foster City, City of Half Moon Bay, City of Menlo Park, City of Millbrae, City of Pacifica, City of Redwood City, City of San Carlos, City of South San Francisco, Town of Woodside, Broadmoor Police Protection District, Granada Community Services District, Menlo Park Fire Protection District, Midpeninsula Regional Open Space District, Mid-Peninsula Water District, Montara Water and Sanitary District, San Mateo County Harbor District, San Mateo County Transit District, and Sequoia Healthcare District will, as required by law, enter into separate agreements with the County's Chief Elections Officer to outline the services to be rendered and to reimburse the County for the costs of said services and supplies.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that (A) the November 6, 2018 Statewide General Election is hereby consolidated with the above-named local elections duly called by their respective governing bodies; and (B) the County's Chief Elections Officer is authorized to render specified election services in conjunction therewith.
